#### INVITATION FOR BIDS (INTERNATIONAL COMPETITIVE BIDDING)

The Government of Grenada (GoG) has received a loan from Kuwait Fund for Arab Development (KFAED) toward the Construction of the Grenada Agricultural Feeder Roads Project Phase III and intends to apply the proceeds of this financial assistance to eligible payments under the contract. Payments by KFAED will be at the request of GoG and upon approval by KFAED and will be subject in all respects, to the terms and conditions of that agreement.

The Ministry of Infrastructure Development, Public Utilities, Energy, Transport & Implementation (MOI) wishes to select qualified contractors for the construction of the Grenada Agricultural Feeder Roads Project Phase III Package-1.

Brief Description of the works: The proposed construction works will include the construction of total of 20.172 km of roads listed below here.

The scope of works includes but not limited to the following:

- General Site Clearance;
- Excavation, Compacted Backfilling, Subbase, Basecourse Construction of Bridges, Drains, Retaining Walls etc.
- Rehabilitation or Reconstruction of Concrete or Asphalt Concrete Pavements Construction of retaining walls and other slope stabilization measure.
- Construction of associated roadside furniture
- Access to nearby properties

There are no restrictions as to countries of eligibility. However, a margin of preference of 5% of the lowest evaluated bid will be allowed in the evaluation of contractors of Kuwaiti Nationality or to a joint venture between them and Grenada contractors. Joint Ventures arrangements are limited to composition of not more than two firms or entities.

Eligible bidders have to submit Full qualification information with their bids establishing their eligibility to bid and qualification to perform the contract if the bid is accepted. Tender and qualification information are to be submitted in the English Language on the prescribed forms inserted in the Bid Documents. Submissions that do not provide the information required, or do not demonstrate the prospective contractor's ability to perform satisfactorily, will not qualify and will not be considered for further evaluation.

Qualification requirements include, inter alia:

- An average annual turnover (defined as billing for works in progress and completed) over the last Five years of United States Dollars (USD) 12 million equivalent for civil works;
- Demonstrable cash flow (including access to credit) of USD 7,500,000 or equivalent;
- Participation as contractor, management contractor or subcontractor, in at least Three (3) contracts within the last Five (5) years, each with a value of at least USD\$30,000,000.00, that have been successfully and substantially completed and that are similar to the proposed works;

A complete set of the Bidding document may be purchased by interested applicants (a) on the submission of a written application to the 1» address below and (b) upon payment of a non-refundable fee of ECS 540.00 or USD 200.00, payable to Accountant General, Ministry of Finance. The Tender document can be picked up at the Ministry of Infrastructure Development, Public Utilities, Energy, Transport & Implementation Office. The request must clearly state "Request for Bidding Documents for "Construction of the Grenada Agricultural Feeder Roads Project Phase III - PACKAGE 1". The Document is available for purchase between May 13th 2019 to June 7th 2019 between the hours of 9:00am to 3pm.

Completed Submissions shall be made in sealed envelopes, clearly marked "BID FOR Construction of the Grenada Agricultural Feeder Roads Project Phase III - PACKAGE 1" and must be received at the SECOND ADDRESS below not later than 2:00 pm July 8th 2019 either delivered by hand or by registered mail. Bid opening will take place at 2:30 pm July 8th 2019.

All bids must be accompanied by a Bid Security of USD 100,000.00

The Ministry of Infrastructure Development (MOID) reserves the right to accept or reject any bid, and to annul the process and reject all bids, at any time prior to award of contract, without thereby incurring any liability to the affected prospective bidder(s) or any obligation to inform the affected prospective bidder(s) of the grounds for MOID action. MOID will not defray any costs incurred by any bidder in the preparation of bids.
